POSITION OVERVIEW

PCIP is seeking a **Practice Transformation Manager** who will oversee tracking and reporting of grant and program deliverables for practice transformation initiatives.

The **Practice Transformation Manager** will be responsible for managing and tracking grant deliverables; building, developing, and managing a team; and developing curriculum to be used to help clinicians stay on top of the ever-changing healthcare landscape and be able to smoothly transition to value-based, quality-driven, patient-centered patient care.

If you're looking for exciting work that moves the needle on patient outcomes, addresses health equity, shapes the future of healthcare delivery, and work in one of the most innovative health departments nationally, then bring your critical thinking skills and ability to process information quickly to this highly public facing and impactful role. This position reports to the Assistant Director of Strategy.

RESPONSIBILITIES

- Team Management & Development
 - Oversee a team of specialists who work in the field on practice transformation throughout NYC
 - Develop and implement staff development activities (e.g. trainings, shadowing, etc.)

- Coach each team member to ensure development towards organizational and personal goals
- Practice Facilitation
 - Manage a small caseload of physician practices and support practices as they work on transformation for success in value-based payments (VBP). Practice transformation projects include work towards practice recognition under the National Committee for Quality Assurance (NCQA) Patient-Centered Medical Home (PCMH) program, Centers for Medicaid and Medicare (CMS)'s Transforming Clinical Practice Initiative (TCPI), and NYS Advanced Primary Care (APC). Will require training ability, EHR expertise, basic data analysis skills, and understanding of change management principles.
- Project/Program Management
 - Serve as implementation and administrative lead on up to two grant-funded, state/federal-program-funded, or city-funded projects
 - Proactively identify and manage issues/risks
 - Create resource plans to ensure that each project is properly staffed and budgeted.
 - Identify strategies and develop metrics and processes to monitor and track progress of the program, establishing clear deliverables and project timelines
 - Coordinate activities with all stakeholders to meet deliverables
 - Coordinate cross team activities to complement the timely achievement of program deliverables
 - Coordinate progress reports to all stakeholders to ensure timely submission of invoices and deliverables
 - Develop modifications to Salesforce CRM workflow, and work with legal teams to ensure timely contract execution and management
 - Perform other administrative duties as needed

QUALIFICATIONS

- Master's degree - MPH, MPA, or other health care related field
- 2+ years professional experience in a healthcare setting
- 2+ years of grants management experience and management experience preferred
- Knowledge of Electronic Health Records, population management, quality improvement, meaningful use and patient-centered medical home
- Knowledge of principles related to payment reform, healthcare landscape and stakeholders (insurance companies, ACA, value-based payments, CMS, etc.)
- Excellent time management, attention to detail, organizational, writing and communication skills
- Excellent project management skills, customer service and relationship management
- Strong computer skills, with proficiency using Microsoft Office, Microsoft Project and CRM experience
